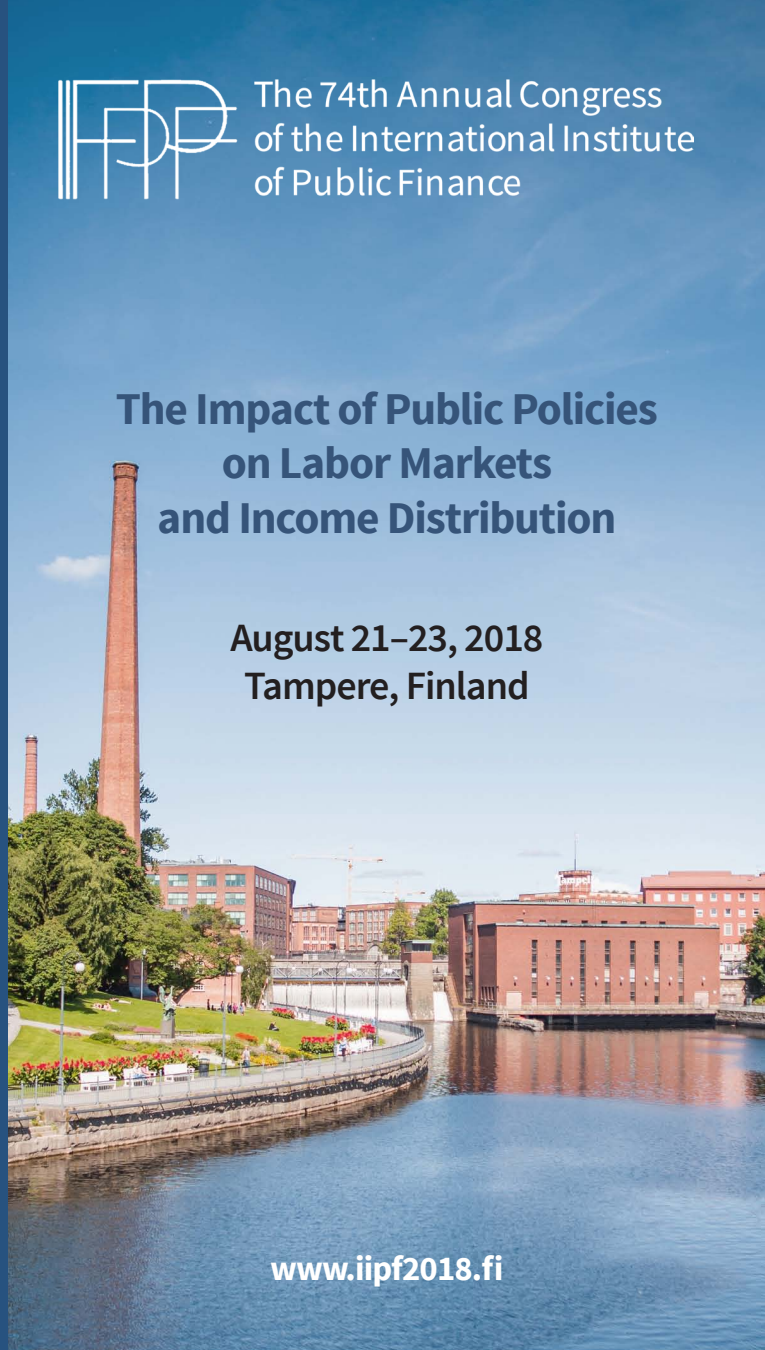

WELCOME TO TAMPERE IN 2018

It is our pleasure to invite you to the 74th Annual Congress of the International Institute of Public Finance (IIPF 2018), held at the University of Tampere, August 21-23, 2018.

Tampere and Finland provide a safe, clean and affordable location to hold the 2018 congress. Tampere is Finland's third largest city as well as the largest inland city in the Nordic countries. Tampere is located on an isthmus between lakes Näsijärvi and Pyhäjärvi, in beautiful ridge scenery. The Tammerkoski rapids running through the city are a nationally recognized landscape.

Tampere was founded in 1779 and the city has a monumental industrial history: the Finlayson cotton mill was the first large-scale industrial enterprise in Finland and it was in fact in Finlayson's factory hall that the first electric light in the Nordic countries was lit.

IIPF

The International Institute of Public Finance (IIPF) is the world organization of public finance economists and has over 700 members from over 50 countries. In an increasingly specialized academic field, the IIPF seeks to generate intellectual interchanges among public finance experts.

The Institute's annual congress is the main forum for its activities, which include organizing academic events, promoting the exchange of knowledge between academics and practitioners of all nationalities, and awarding prizes for outstanding academic achievements.

The congress also provides an opportunity for the IIPF governing bodies to convene (Board of Management, General Assembly of Members). The IIPF is currently administered by an Executive Committee consisting of President Joel Slemrod (University of Michigan, US) and two Vice Presidents, Wojciech Kopczuk (Columbia University, US) and Monika Büttler (University of St. Gallen, Switzerland). The legal and administrative seat of the non-profit organization IIPF is in Munich, Germany.

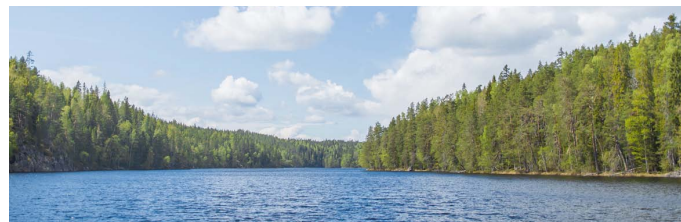

VENUE

The congress will be held at the University of Tampere main campus. The venue is located in the center of Tampere and is easily accessible, at a 10 minute walking distance from the railway and bus stations. Address: Kalevantie 4.

Conference hotels are located within 5-10 minutes walking distance.

HOW TO GET THERE

The distance to Tampere from Helsinki-Vantaa Airport is 175 kilometers, 1.5-2 hours by train or 2-2.5 hours by bus directly from the airport.

Tampere-Pirkkala Airport is located about 17 kilometers from Tampere city center, approximately 20-30 minutes by bus or taxi.
